Minutes of the meeting of Sub-Committee of NCVT on Training norms and courses held on 31st July, 2014

A meeting of the Sub-committee of NCVT on Training Norms and Courses was held on 31st July, 2014 in Committee Room, C-Wing, New Delhi under the Chairmanship of DG/JS. List of participants who attended the meeting is at annex -III.

DG/JS welcomed all the members of committee and gave a brief introduction to the major initiative taken by DGE&T for improvement in quality of curricula, for imparting demand driven and industry relevant training in ITIs. He further added DGE&T is implementing Craft Instructor Training Scheme for overall skill enhancement of instructors of ITIs through its field institutes namely Craft Instructor Training Institute at Chennai,Advanced Training Institutes (ATI), Advanced Training Institutes for Electronic and Process Instrumentation (ATI-EPIs),Foremen Training Institutes (FTIs), Model Industrial Training Institutes. Modular pattern of Craft Instructor Training in place of conventional one year training was introduced in CTI and ATIs with effect from session started from August, 2009.However in place of modular pattern NCVT during its 41st meeting held on 30th April, 2014 approved one year comprising of two semesters each of six months under CITS Accordingly, all mentor council were assigned task to revise the curricula of trades under CITS in following structure.

For Engineering trades:

1st Semester by combining Trade Technology I (TT-I) and Engineering Technology (ET)

2nd Semester by combining Trade Technology II (TT-II) and Training Methodology (TM)

For non-Engineering trades:

1st Semester by combining Trade Skill-I and Vocational Calculation & Science

2nd Semester by combining Trade Skill-II Training Methodology

Thereafter, he requested Director of Training (DT) to give presentation on the agenda item.

DT informed the committee that NCVT in its 41st meeting held on 30.4.2014, has authorized Sub-Committee of NCVT on Norms and Courses for approval of new courses /courses revised and updated / deleted as recommended by mentor councils of the respective sectors under all schemes including CITS. Thereafter point wise agenda items were taken up for discussion.

Item No. 1: Approval of Course Curricula revised/updated by Mentor Councils for Theory and Practical content, for trades under Craftsmen Instructor Training Scheme(CITS).

DT informed the Sub-committee that DGE&T initiated the task for revision of curricula of existing CITS courses through 11 Mentor councils of respective sectors. Following curricula were developed.

Trade specific: Trade Technology I (TT-I) and Trade Technology II (TT-II)

Trade Group specific: Engineering Technology (ET)(for Engineering trades)/ Vocational calculation & Science (for non Engineering trades)

Common for all trades : Training Methodology (TM)(Practical will be trade specific)

DDG (T) requested mentors of the respective sectors to give presentation on the recommendation of MC for their respective sectors. Thereafter, Sector wise presentation was made by the mentors of that sectors including the comments / suggestions received and action taken thereupon and following points were discussed and concluded uniformly for all Sectors.

i. Trades under CTS for which seating capacity at all India level is very small, no new CITS course need to be developed as the seats under CITS would not be fully utilized after all instructors of that trade are trained.

ii. To establish a mechanism for mapping curricula of trades under CTS with curricula of concerned trades under CITS so that any up date in CTS courses is immediately included in CITS courses. This should also include newly created CTS courses.

iii. New CITS courses should be such that they have broader coverage and cater to the need of more that onel CTS trade falling in that sector, as far as possible.

iv. Clear listing of additional machinery which ATIs would required to implement the new/revised CITS courses.

v. Eligible qualification i.e. educational/technical and experience, for joining CITS courses should be clearly mentioned in each syllabi of CITS keeping in view the CTS course it will cover. In case of Degree or Diploma, full name and duration as per AICTE or relevant authority should be clearly indicated on syllabus.

The committee discussed the Sector wise details of changed name of CITS trade and corresponding CTS trades for which CITS trade trained instructor would be eligible to teach. The list of the approved name of CITS trades and corresponding CTS trades is placed at annex-I.

After detailed discussions, following decision were also taken for syllabi of TT-1 and TT-2 :

 Topics on CAD be included in "Reading Of Drawing and Arithmetic" course under CITS.

- To include a standard course of six month duration under CITS, which would be offered uniformly for instructors of those trades of CTS where no CITS courses are available. Content to be developed by CSTARI, Kolkata by including PoT, Vocational Skills and soft skills.
- To permit the passed out trainees CoE to take admission in CITS after completing a bridge course of six months. All mentors were advised to develop a bridge course of 6 months in their respective sectors. The bridge course would be offered by ATIs.
- Textile ministry to share their need of industry relevant MES courses so that such MES courses could be included under SDI scheme.
- In case of sectors "Tour and Travel" and "Beauty and Wellness"; the Vocational Calculation & Science module be replaced with Soft Skills module. CSTARI was asked to develop this module with adequate industry partnership.

Thereafter, Director CSTARI presented the syllabi of Workshop Calculation Science and Engineering Drawing ,common for group of trades (except for group no. VI) as per details of group and trades covered in each group given at Annex-II. He also presented the syllabus of "Training Methodology", common for all trades. These syllabi were approved by the Sub-Committee.

Item No. 2 Defining trade wise number of supernumeries for all trades.

NCVT during its 36th meeting held in December, 2007 approved that supernumery seats in ITIs be kept as 30% without compromising with quality of training which will ensure optimal utilization of available infrastructure created for training.

In order to avoid any ambiguity while admission following supernumeries seats were approved depending the batch size for the trades.

Concluding the discussion, DG/JS informed the members that DGE&T has taken initiative to develop high employment potential courses for specific needs of Industries through flexi MoUs. Detailed policy guidelines have been finalized with the approval of competent authority .The courses so designed by industry/employer shall be put before 'Sub-Committee of NCVT on Norms and Courses' for approval. The Sub-Committee may co-opt the Chairman of Mentor Council, or his representative, Mentor of Sector and one external expert if needed.The meeting ended with a vote of thanks to the Chair.
