MINUTES OF THE MEETING

Minutes of 2nd Meeting of Sub-Committee of National Council for Vocational Training (NCVT) Dealing With Affiliations for the session 2016-17, held under the Chairmanship of Shri Asheesh Sharma, Joint Secretary, Ministry of Skill Development on 19th August, 2016 At 2.30 P.M. in the Main Committee Room, C Wing, Shram Shakti Bhawan, Rafi Marg, New Delhi.

The list of members who attended the meeting is at Annex. 'A'.

At the outset Director (T) welcomed all the members.

<u>Item No.1:</u> Confirmation of the minutes of the 1st meeting of the Sub-Committee of National Council for Vocational Training (NCVT) dealing with affiliation.

- a. The sub-committee reviewed the minutes of the previous NCVT Sub Committee meeting held on 03.05.2016, with minutes circulated on 30th May, 2016 (Appendix-I). As the members of the Sub-Committee had no comments, the minutes were accepted as confirmed.
- b. The **Action Taken Report** (ATR) on the recommendations of the meeting was reviewed. DG/JS asked QCI to take action on the pending points pertaining to them from the last meeting and submit compliance report. QCI assured to submit compliance on pending ATR points.
- c. Director (T) briefed the sub-committee about constitution and recommendations/suggestion given by the committee comprising of members from the States of Rajasthan, Uttar Pradesh, Andhra Pradesh, Maharashtra and Bihar to decide on capping of units / trades with respect to population of the existing ITIs/trades/units in the district. DG/JS expressed his desire to hold a meeting with the committee. He also informed the sub-committee that the recommendations/suggestion given by the committee will be discussed with various State Directors before implementing the same.

The committee welcomed the proposal.

Item No. 2: Decision of Miscellaneous Court Cases

The sub-committee was informed regarding the decision of the Hon'ble High Court, for three Court cases Speaking orders were issued in compliance with the Hon'ble High Court Decision (**Annexure II**).

Further, for six more cases, the Hon'ble High court had passed a common judgement **(Annexure-III).** It was placed before the subcommittee members.

It was decided that all these cases (3+6) should be presented in a tabular format eliciting details of WPC, case, decision and date of decision, etc.. The sub-committee consented to grant affiliation for these six cases in line with Orders issued by the Hon'ble High Court.

Item No. 03: De Affiliation cases

DT presented before the Sub Committee members list of **62** cases of **Odisha** State de-affiliated (**Annexure-IV**) as per request from the State Directorate. She also added that out of 45 cases received for de-affiliation from the State Directorate of **Rajasthan** State, **14** cases have been de-affiliated (as per decision made in the meeting of sub-committee for Norms and Courses held on 08.07.2016, Agenda item No. 3).

These were placed for Ex post facto approval of the Sub- Committee.

Remaining **31** cases of Rajasthan were also placed before the Sub Committee for de affiliation (Annexure V).

The sub-committee approved de-affiliation of all the cases (62 Odisha & Rajasthan14+31).

<u>Item no. 04</u>: Consideration of recommendations in respect of affiliation cases received from QCI.

The Affiliation cases of Existing ITI(s), received after accreditation from QCI had been processed at DGT. *Out of these, the sub-committee approved granting affiliation to 20 Govt. ITI(s) and 44 Private ITI(s). The list of ITIs is placed at Annex. VI.*

Item no. 05: Any other item with the permission of the Chairman.

 WPC no. 797/2016 in the matter related to Ajeet private ITI, Rajasthan (petitioner) v/s DGE&T

Hon'ble High Court of Delhi under order dated 1.02.2016 had ordered that "As and when such an application is filed, the same is directed to be considered and disposed of by the respondents in accordance with law". Accordingly, the application of Ajeet Pvt. ITI seeking Electrician 6 (2+2+2) units is placed before the committee for re-examining the proposal in context of existing norms' (Annexure-VII).

The Sub Committee recommended granting affiliation to Ajeet private ITI, Rajasthan additional Electrician- 4(1+1+2), Total 6 (2+2+2) units w.e.f. August 2016.

 WPC no. 6848/2016 relating to Utthan fire & safety private ITI, Dausa Rajasthan v/s DGE&T

Hon'ble High Court of Delhi under order dated 11.08.2016 has ordered that "....schedule, as prescribed by the DGT vide their letter dated 17.05.2016, which specified the last date of meeting of NCVT Sub-Committee as 12.08.2016 will be appropriately modified. If the records of the petitioners are in order the same would be considered for the academic session 2016-17." (Annexure-VII).

The Sub Committee decided that the Building Completion Certificate of the ITI to be verified from Secretary, Urban Development Department, Rajasthan by Rajasthan State Directorate. DGT will forward the documents to Department of Technical Education, Rajasthan to get the same verified from the concerned department.

However, the committee agreed to grant conditional affiliation to the ITI subject to verification of Building Completion Certificate from Secretary, Urban Development Department, Rajasthan.

- 3. Any other issue:
 - NABET to follow policy/guidelines issued by DGT for carryout accreditation in respect of all the States/State of Rajasthan.
