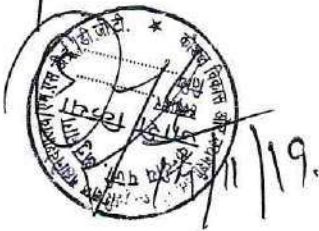

Minute of Meeting

1st Industry MoU Signing Approval Committee Meeting held on 11th November 2019 at Conference Hall, 3rd Floor, Kaushal Bhawan B-2, Pusa Road, Karol Bagh, New Delhi – 110005

As per DGT order ref. **DGT-NSTI0NI/5/2019-O/o DIR (CFIs)** dated **1st April 2019** regarding review and approval of various MoUs being signed (proposed) between NSTI's and Industry/ Organization/ Private Party under CSR, first meeting of the committee was conducted on **11th November 2019** at DGT office Kaushal Bhawan, New Delhi.

The meeting was conducted under the chairmanship of **Director General (Training), DGT**. The committee deliberated on various agenda items, agenda wise the discussion points and decision/ recommendation of the committee are elaborated below:

Agenda No 1: Termination of MoU between ZOHO and NSTI Chennai

- An **MoU** was earlier signed between the **Zoho Corporation Pvt. Ltd., Chennai and NSTI Chennai** for conducting courses in "Operate a business using App/ Zoho App" of 36-48 hrs duration was reviewed by committee.
- The committee members observed that it was good pilot with 193 candidates already being trained, however it is a fee-based model with fee being paid to Zoho. Also, training implementation is being done by 3rd party i.e. ZOHO Training partner M/s ITK Education Services Pvt. Ltd.
- **Action:** The committee recommended that the above training shall be discontinued and MoU between NSTI, Chennai and Zoho shall be **terminated**. The committee decided that going forward NSTIs are recommended to opt for **non-fee/ free** courses. Should any fee be charged from students under CSR initiatives, it should be charged directly by NSTI, with revenue to Central Govt.(or State Govt. wherever applicable).

Agenda No 2: Approval of MoU between NSTI Chennai and Jaquar Foundation

- **Jaquar Foundation** has extended their support in setting up of labs in **5 NSTIs** and as a first step with **NSTI, Chennai** where plumbing course is being currently run. Support includes Lab Setup (excluding Civil Works), Capacity Building of Trainers (on latest equipment and tools provided, and teaching material/method), Guest Lectures (Industry Expert), Addon Certification (from Jaquar, post their own assessment). They are ready to

pick up '**Electrical' labs'** upgradation, since Jaquar has recently ventured in that segment as well.

- i. The committee reviewed the proposal and **approved MoU** for being signed between NSTI, Chennai and Jaquar Foundation.
 - ii. The committee also recommended that to conduct any training workshop/ event at this facility, for Jaquar faculty, same would be allowed after approval of competent authority and similarly, for skilling of underprivileged during the Institute's vacation period. CFI section to take up necessary approvals.
 - iii. The overarching objective should be to impart skills (including upskilling and reskilling) and not a revenue generating activity.
- **DG (T)** recommended that **NSTI, Kanpur** may be selected for plumbing lab setup/ upgradation amongst other 4 locations including 'Electricals' lab of NSTI's.

Agenda No 3: Collaboration between NSTI Bengaluru and GTTC Bengaluru, for jointly conducting skill training in CNC and CAD Courses for better Utilization of infrastructure and underutilized Lab Facility of NSTI-2 Bengaluru

- **Dr. S. Selvakumar, Secretary Skill Development, Entrepreneurship & Livelihood Department Govt. of Karnataka** formally requested to **Secretary, MSDE** through **DO letter DO letter No: SDEL 62 SSM 2019**, dated **24.09.2019** for provisioning of space at NSTI-2 Bengaluru to GTTC for conducting both long term and short-term skill training programs and ToT.
- Punita Bhatia, Deputy Director (DGT) apprised the committee members about the meeting held in this regard with Director NSTI, RDSDE Karnataka and Managing Director GTTC Bengaluru on 1st Nov. 2019. The committee was apprised about GTTC's commitment to provided 20% discount on fee for training NSTI students. Also, free training for candidates with state domicile/Aadhar.
- **Action:** The committee **approved for MoU signing** in this regard. The committee recommended that sharing of common expenses between parties towards administration, maintenance and utilities should be clearly defined in MoU.

Agenda No 4: CSR MoU with HPCL - Sponsorship for setting up Solar Tech Lab - NSTI, RDSDE Mumbai

- **HPCL Mumbai** under the CSR activities offered support for installation of Solar Technician Laboratory at NSTI, (under RDSDE) Mumbai and MoU was signed by Shri. K S Shetty (CGM, HR) HPCL Mumbai and NSTI Mumbai Director RDSDE Sh. Hari Nath Babu. NSTI Mumbai has recently introduced new age course "**Solar Technician (Electrical)**"
- HPCL's contribution under this MOU would be limited to Rs.36,00,000/- (Rupees Thirty-Six Lakhs Only) including taxes and cost towards manpower, equipment, Installation and commissioning of the Solar Technician (Electrical) Laboratory.
- **Action: Committee approved the MoU** and suggested that team may proceed with implementation.

Agenda No 5: CSR Initiative of MSIL to support NSTI Kolkata in automobile sector

- A meeting was held on 2nd July 2019, chaired by **DG(T)/AS**, with **Executive Director MSIL, Sh. A. K. Tomer**, to set up **MMV and allied Trades' labs** by **MSIL** under **CSR initiative**. It was agreed upon that MSIL Gurugram, would be setting up labs in NSTI with MMV & allied trade under CSR Initiative. In this regard team of MSIL visited and finalized NSTI, Howrah for upgradation. A phase wise implementation plan was submitted by MSIL regarding same.
- **Action:** Committee approved for the upgradation activity. DG(T) suggested that the activities may be started at the earliest with visible progress by end of this year.

Agenda No. 6: Revised Office Order regarding compliances to be met by NSTIs when signing CSR-MoUs

- The committee members recommended that NSTIs must be advised to mandatorily seek committee approval before signing of MoU under CS. Also, fee is charged in form shall be 100% state government/ or central government only.
- The committee also recommended activities under MoU signed under CSR should be such that that CTS/CITS/ATS students may benefit from the same. Such activities under MoU may be for the benefit of underprivileged and any such special groups and shall not result in profit making.

- Also, if the CSR/ Industry partner intends to utilize NSTI facilities for any activity/ training/ workshop, same shall be done on prior approval of competent authority and should not result in revenue generation/ profit making.
- **Action:** A revised office order would be issued through CFI and DDG, to all Directors' (NSTI) in this regard

The meeting ended with a vote of thanks to Chair.
