G.S.R.....(E).-In exercise of the powers conferred by the proviso to article 309 of the Constitution, and supersession of the Directorate of Training, (Vocational Training Program for Women),Directorate General of Employment and Training Group 'C' Non-Gazetted (Ministerial) posts Recruitment Rules, 2003 notified vide GSR 396 dated 31-Oct-2003 , **except** as respect things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Office Superintendent (Women Training), Group 'B' Non-Gazetted (Ministerial) in the Directorate General of Training (Women Training), under Ministry of Skill Development and Entrepreneurship, namely:-

Short title and Commencement.- (1) These rules may be called the Ministry of Skill Development and Entrepreneurship, Directorate General of Training (Women Training), Office Superintendent Group 'B' Non-Gazetted (Ministerial) Recruitment Rules, 2024.

(2) They shall come into force on the date of their publication in the official Gazette.

- 3. Number of posts, classification, and Level in the pay of Matrix- The number of posts, their classification and Level in the pay of Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age limit and other qualification, etc.- The method of recruitment, age limit, qualifications and other matters relating to the said posts, shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 5. Disqualification-No person shall be eligible for appointment to the said post,
 - a. who has entered into or contracted a marriage with a person having a spouse living; or
 - b. who, having a spouse living, has entered into or contracted a marriage with any person,

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing

so, exempt any person from the operation of this rules.

- 6. Power to relax- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving- Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the other backward classes, economically weaker sections, ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time, in this regard.
