Renewal of MoU dated 03 October 2023

Memorandum of Understanding (MoU) dated 03 October 2023, is amended by and between:

Skills Development Network, an Indian Trust registered under the Foreign Contribution (Regulations) Act, 2010 with its current registered office at 6th Floor, Bhive Premium, 48, Church Street, Bengaluru-560001, Karnataka (with previous address at Tower - 3, 6th Floor, SJR I Park, EPIP Zone - I, Whitefield Road, Bengaluru - 560066, Karnataka) (herein referred to as the "**Foundation**", which expression shall, unless it's repugnant to the meaning or context thereof, be deemed to mean and include its successors in interest and assigns) of the **FIRST PARTY.**

AND

Directorate General of Training (DGT) under the Ministry of Skill Development & Entrepreneurship (MSDE), is the apex organization for the development and implementation of vocational training schemes at the National level, having its registered office at New Kaushal Bhawan Office, Ministry of Skill Development and Entrepreneurship, 7th Floor, New Kaushal Bhawan, Near Safdarjung Railway Station, Chanakyapuri, New Moti Bagh, New Delhi, Delhi-110023 (herein referred to as the "DGT" which expression shall, unless it's repugnant to the meaning or context thereof, be deemed to mean and include its successors in interest and permitted assigns) of the SECOND PARTY.

Foundation and DGT shall hereinafter individually be referred to as a "Party", and collectively as the "Parties", as the context may require.

Whereas, in compliance with section 4.12 (b) of the MoU, Parties have mutually agreed to amend the MoU as per the following:

1. Amendment in the MoU:

The existing Section 4.1 Term & Renewal

This MoU shall be effective from the Effective Date as mentioned above until **01 year** or completion of the Program activities as mentioned under this MoU or terminated as per the terms of this MoU, whichever earlier. The MoU may be renewed by providing the other Party with prior written notice of thirty (30) days and on mutual agreement of Parties in writing, depending on the output and the impact of the existing MoU. **Is amended as follows:**

This MoU shall be effective from the Effective Date as mentioned above until **02nd October 2026** or completion of the Program activities as mentioned under this MoU or terminated as per the terms of this MoU, whichever earlier. Any further renewal/extension of this MoU shall be done by executing a new MoU.

2. The following addition is made to the Annexure II - Objectives and Scope of the program.

- Foundation will provide the Digital Content for the 2nd year Employability skills (for 60 hrs) to the Industrial Training Institutes (ITIs) and National Skills Training Institutes (NSTIs) students under DGT.
- b. Foundation will conduct Training of Trainers (ToT) for at least 600 trainers of NSTI and ITI ecosystem on the usage of Employability skills content.
- c. Foundation will offer AI based counselling and mentorship to atleast 1000 students on pilot basis, as and when available on the platform.
- d. Foundation will conduct ToT programs for CITS trainees on Employability Skills at NSTIs, targeting 1000 CITS trainees.
- e. Foundation will develop and integrate 7.5 hrs of "AI for all" content in the Employability Skills 120 hrs content for ITI students.
- f. DGT and Foundation will pilot the creation of AI-enabled Long-Term domain course(s) on GenieAI platform, which will be run and used by trainees, and will compile feedback on the course(s) and the overall program.
- g. The Parties will mutually select one or more than one NIMI course content that has video assets.
- h. Foundation will use these video assets to create a new course on GenieAI and will train its AI tutoring agent to create MyTutor functionality for this course.
- i. Foundation will compile feedback of the new course with at least 100 students (respondents) from at least three ITIs/ NSTIs and share with DGT. The details of ITIs/NSTIs and trainees to be provided by DGT.
- j. On successful completion of the pilot, DGT to host the content on their Digital Learning Platform so that it is available to all the students across all the ITIs and NSTIs.

This amendment will be effective as on 03 October 2024. All other terms and conditions in the MoU mentioned herein shall remain in full force and effect as per the terms of the MoU.
