It is to inform that 125<sup>th</sup> AITT is scheduled for Non-ITI/ Fresher apprentices. All the Non-ITI/ Fresher apprentices who have completed their training on or before 15<sup>th</sup> Jan, 2026 are eligible to apply, provided they meet all other mandatory criteria as per the Examination Eligibility. **3. CBT Exam Pattern:** There will be two examination sessions consisting of three/ two papers for Engineering/Non-Engineering trade respectively.

**Engineering trades:**

Exam-1: Trade Theory - 50 questions, 100 marks

Exam-2: Workshop Calculation & Science (WCS) - 25 questions, 50 marks and Employability Skills (ES) - 25 questions, 50 marks

Exam-1: Trade Theory - 50 questions, 100 marks

Exam-2: Employability Skills (ES) - 25 questions, 50 marks

**4. CBT Examination Fee:** Apprentices are required to pay the fee while registering for exam through online mode only. The fee paid is non-refundable. The functionality for fee payment is integrated in apprentice login. The fee is as below:
