**DRAFT NOTIFICATION**

G.S.R. 267(E). – *In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Ministry of Skill Development and Entrepreneurship, Directorate General of Training (except Women Training), (Group 'B' Technical Posts) Recruitment Rules, 2025 thereto namely;-*

1. (i) *These rules may be called the Ministry of Skill Development and Entrepreneurship, Directorate General of Training (except Women Training), (Group 'B' Technical Posts) Amendment Rules, 2026.*

*(ii) They shall come into force on the date of their publication in the Official Gazette.*

2. *In the existing Ministry of Skill Development and Entrepreneurship, Directorate General of Training (except Women Training), (Group 'B' Technical Posts) Recruitment Rules, 2025,*
