Sir / Madam,

This is reference to Minutes of the 26th Meeting of the Standing Committee on Accreditation and Affiliation (SCAA) held on 18.07.2025 vide which the de-affiliation of trade/units of Industrial Training Institutes, was recommended and sent to DGT.

The matter has been examined and discussed and the competent authority has decided to de-affiliate the following Industrial Training Institute of Maharashtra w.e.f session 2025-26. The details are given below:

It was found that 415 ITI had remained vacant without any admissions for six years. In November 2024, the DGT gave these 415 ITI a final chance to submit their grievances before de-affiliation. Thirteen ITIs submitted grievances and have been temporarily excluded from de-affiliation. 2 However, Joint inspection committee has mentioned serious shortfalls and non-operational for long time. It is crucial to verify their infrastructure and machinery status against norms. The Regional Directorate of Skill Development & Entrepreneurship	The Committee, after due consideration of the reply submitted by the ITI, found the same to be unjustified; hence, the de-affiliation order dated 28.08.2025 shall continue. However, if the ITI intends to operate, it may apply for a fresh affiliation application whenever the portal is opened, as per norms.

			<p>(RDSDE) and the respective State Directorate are directed to conduct joint inspections and submit reports based on NIMI inspection through DGT order dated 23.05.2025. Joint inspection committee is recommended for de-affiliation.</p> <p>3 Subsequently, reports were put up in 23rd SCAA. As per reports, serious shortfalls observed by the competent i.e. i. Electricity bill is on "Prabha School of Secretary", not on ITI name.</p> <p>ii. Machineries are not in working condition as Machineries are not in working condition as per ICVC report.</p> <p>iii. Nursing school is running in the same campus.</p> <p>iv.
