Madam/Sir,

This is in reference to the proposal received from the State Directorate, Haryana, for the de-affiliation of one Private ITI, which was forwarded to DGT with the in-principle approval of the Principal Secretary, YE&E-cum-Chairman, HSDEC.

2. The matter was discussed in 29th Standing Committee on Accreditation and Affiliation (SCAA) in its meeting held on 08.05.2026 and based on the recommendations received from State Directorate Haryana, SCAA accepted self-surrender of trades/units of 01 Private ITI w.e.f. session 2026-27, and same has been approved by the Competent Authority. The details of the ITI is attached at **Annexure - I**.

3. The ITIs and the State Directorate shall ensure that all the trainees who were already enrolled in the previous session(s), complete the training duration and no fresh trainees are admitted.

Pvt. ITI, Village Sunarian Khurd, Beri Road, Rohtak on 06.06.2025 wherein, several deficiencies were found during this inspection. 2. Due to the deficiencies observed, the Directorate issued a Show Cause Notice to the ITI on 03.07.2025. As a punitive measure, the admission seats were temporarily suspended for the academic session 2025-26 by State Directorate. 3. The management of C.R. Pvt. ITI submitted their reply dated 15.07.2025 to the Show Cause Notice. 4. The Directorate issued an order dated 17.09.2025 directing a Joint Inspection of the ITI to verify compliance and current status. 5. A Joint Inspection was carried out on 17.09.2025 at the institute. During this inspection, serious irregularities were observed. On the same day of the joint inspection, the Principal of C.R. Pvt. ITI submitted a written statement requesting that they want to discontinue the functioning of the Private ITI. 6. Based on the above facts, the Directorate of Skill Development & Industrial Training, Haryana, has recommended de-affiliation of C.R. Pvt. ITI, Sunarian Khurd, Rohtak vide their letter dated 12.03.2026 with the in principal approval of Principal Secretary, YE&E- cum chairman, HSDEC.	SCAA accepted the ITI's request for the self-closure of the ITI.
