Subject: Corrigendum of Minutes of 29th Meeting of “Standing Committee on Accreditation and Affiliation (SCAA)” held on 08.05.2026 and de-affiliation order in respect to OM Private ITI, Morena (PR23001088)- regarding.

Sir/Madam,

This is in reference to the Minutes of the 29th Meeting of the Standing Committee on Accreditation and Affiliation (SCAA) issued on 01.06.2026 and the consequential De-affiliation Order of even number dated 19.06.2026, whereby “OM Private ITI, Morena (PR23001088)” was de-affiliated pursuant to the decision of the 29th SCAA Meeting (Ref.: Annexure-4, Sr. No. 5 of the Minutes).

2. Subsequently, a representation has been received from OM Private ITI, Morena (PR23001088) requesting reconsideration of its case. The ITI has submitted that its reply to the observations/remarks of the 29th SCAA Meeting was transmitted through email on 26.03.2026, which was the prescribed last date for submission of the response. The ITI has further submitted that, the email was transmitted without the requisite supporting attachments, which were subsequently furnished on 30.03.2026.

3. The representation has been examined. It has been verified from the official email records that the email conveying the reply was received on 26.03.2026, i.e., within the prescribed timeline, though without the attachments. In view of the above, and considering that the ITI had initiated submission of its reply within the stipulated period, it has been decided, in the interest of ensuring due consideration of the representation and in accordance with the principles of natural justice, to reconsider the case.

4. Accordingly, the remarks recorded against OM Private ITI, Morena (PR23001088) under Annexure-4, Sr. No. 5 of the Minutes of the 29th SCAA Meeting issued on 01.06.2026 shall stand substituted with the following:

"A joint inspection of the ITI shall be conducted by the concerned State Directorate and RDSDE Madhya Pradesh to verify the removal of identified deficiencies as claimed by the ITI in its reply .

The date of inspection shall be decided by the State Directorate in consultation with RDSDE Madhya Pradesh. The inspection report shall be submitted to the DGT within one month from the date of issuance of the minutes of this meeting for consideration in the next SCAA Meeting."

5. Consequently, the "De-affiliation Order of even number dated 19.06.2026," insofar as it relates to OM Private ITI, Morena (PR23001088), stands withdrawn, and the case shall henceforth be dealt with in accordance with the Minutes of the 29th SCAA Meeting issued on 01.06.2026, as amended by this Corrigendum.
